## **PRESIDENT'S REPORT**

My report covers a much shorter timeframe than usual, with our last AGM being held in late August 2020 due to the effects of Covid-19 limitations on club gatherings during last year. The Club's first Board under the new constitution (replacing previous Committee arrangements) will only have been in existence for about nine months at the time of this year's AGM; however, we have had a busy time of it none the less.

A major priority from the outset was to pursue opportunities to install a synthetic green - a project which was overwhelmingly endorsed at last year's AGM when an indicative vote was asked of those attending. Our first approach was to file an application for a grant from Sports and Recreation – Phil Hobbs undertook this task on our behalf and presented a professional paper, as he had on previous successful occasions, and we had a nervous wait until February to unfortunately find out that we had been unsuccessful. A huge number of applications had been submitted from all over Tasmania and interestingly (in a way) only one bowls club was successful with a request for funds for renovations/modifications as we had done the year before.

The Board held an extraordinary meeting in the week following the advice and it culminated in the appointment of a sub-committee comprising the President, Vice President and Treasurer, who were charged with exploring available options. This sub-committee met with our bankers and the preferred installer of the green and subsequently arrangements were put in place to present a business plan to the Board and to the members before a General Meeting of the members. The Board agreed that it would not present any specific recommended position ensuring that it would be a vote of the members based upon all the risks and benefits deduced from the business plan and discussions at the meeting itself.

We continued the good work of previous years through a busy program that increased the social, community and dollar value for the Club through, amongst other things, the running of our corporate events. This year David Anderson stepped back from the comprehensive commitment to the tasks he carried out in previous years and he predominantly focused on being the Club's point of contact. Arrangements were put in place for individual events to be managed by the Board's directors on a rostered basis; in effect, each director was responsible for events occurring within a specified month. The 'unlucky' loser of this arrangement was Mark Quinane who had a very high workload during December along with his match manager duties and the running of the Turkey 4s event. The Board will fine-tune the methodology of allocating events for the coming year. At the time of writing David has since advised the Board of his wish to entirely relinquish his corporate events role and arrangements are in place for the temporary contact person to be our Secretary until such time as the new Board arranges otherwise. The Board is extremely grateful for David's contribution over recent years, as indeed it is for the assistance of the many volunteers especially those who frequently provided tutoring at these corporate events.

With the traditional concept of afternoon tea breaks being abandoned through Covid-19 restrictions, our greenkeeper, Andrew (Alby) Norris, came up with the great idea of having a sausage sizzle after the game to be cooked by premier and second division players on alternate weeks i.e. home games. A \$5 payment (as per previous afternoon tea arrangements) provided for a sausage and bread for both the payee and his/her direct opponent and so a good social ending to the day's play occurred – many players from visiting clubs commented favourably about it. Together with the proceeds from large sales of raffle tickets, the Club was able to put on an end of

season food and drinks night for the members and still have money left over for the club. Well suggested Alby – we had a good night at the end of it all which was all part of your grand plan.

While the Board still has the completion of the renovations work as another high priority goal, a small number of improvements to club facilities has occurred since our last AGM. The top club house was painted and fitted with a new carpet courtesy of a donation from Peri Buckley; Derek Osman provided a defibrillator for the top clubhouse; Lindsay Lovell provided an ice machine for the bar. The Club purchased 3 bar tables and replaced a 15 – 20 year old dishwasher (which died on the job) with a smaller commercial one – both these decisions proved to be very popular amongst members. Our chiller system for tapped beer had to be replaced and our cool room cooling equipment had to be repaired.

It was once again terrific to see so many of our pennant teams make the finals. All four of Thursday's teams made the final four and divisions 1 and 3 won their grand finals. The Wednesday competition had one out of the two divisions represented in the finals and Saturday pennant had five of the seven teams make the finals, of which premier division and division 5 took out the grand finals. A magnificent effort and congratulations to all concerned – how fabulous is the record of the Thursday women's division 1? Of the 10 contested grand finals in the past 11 years (2020 final not being contested due to Covid-19 restrictions in place) Sandy Bay has won all 10. At the time of writing this report the state finals have not yet been held - so Go the Bay!

A number of individual honours were gained at BTS and state level and are mentioned in our Match Manager reports. A team comprising Scott Booth, Lucas Howell (still a junior player), Ryan McCoull and Kegan Booth (skip) won the BTS Men's Fours. Yvonne and Peri Buckley were part of a winning combination in the BTS Women's Fours. Peri Buckley won the BTS Champion of Champions Open Women's Singles. At state level Ian (Salty) Salt was on a golden run in the B grade events – as was David Lovett to a similar extent – when they were part of winning combinations in the Fours (with Charles Thomas and Bill Mottershead; together to win the pairs; and then Ian ran out of steam at the semi-final stage of the Singles. A great effort by all concerned.

Personal milestones in pennant were achieved by Jimmy Roussos (400 games), Chris Bye (300 games) Gill Pratt (200 games), Alby Norris (200 games) and Glenn Pearce (200 games). Phil Hobbs also reached 200 in his last game. Terrific to see such commitment to the Club.

Once again, our volunteers have been to the fore in a number of areas. John Quinn and his sponsorship sub-committee have again done a terrific job. Richard Wilson, Pat Wilkes and Michael Seddon have once again managed the Barefoot Bowls competition which has been an enjoyable social and competitive event each Wednesday evening during warmer months. Bruce Price continued the good work running the Friday afternoon social bowls. Phil Manning has pulled up stumps on the Bar Manager work that he has undertaken over the past 10 years – thank you for being so generous with your time Phil. So many more people have helped with catering, bbqs, tutoring, raffles, Saturday salad rolls, running social bowling events – the Board has agreed to hold a special evening to demonstrate our gratitude to all of our volunteers, whose work is so important to the Club. It is interesting to note the prevalence of partners amongst our volunteers and Board directors. Often this year we have, for example, had Hilary Johnston and John Quinn; Jan and Phil Hobbs; Sandra and Graeme Main; Adrienne and Rod Calnan; Yvonne Bennett and David Lovett; Maxine Munro and Mark Quinane and quite a few others helping out where necessary. Thank you to all.

Special thanks again to our two employees for your professionalism – Gaele Welling behind the bar and Andrew Norris preparing the greens.

At the end of my second and final term as President, I can reflect on a period of consolidation where, with the help of my fellow Board members, we have a Club that has had success both on the green and off it and for the most part the Club has a good vibe about it. I don't for one moment believe that everyone out of 130 or so members is happy with proceedings all the time, but I do genuinely believe that, overall, the Club is in a good place. Members have commented to me about the "feel good" mood that is prevalent and that is the reward our Board members can take. Our Board consists of hard working people who like to do their individual tasks professionally – and in turn all on the Board appreciate the value of the members of the executive in particular. Thank you to Rod, Yvonne and David for your individual inputs throughout the year.

Finally all the very best to the new Board and the members for the 2021 – 2022 season.

## MAINTENANCE

Below is a list of tasks carried out this year:

- Clean out the spouting on the main clubhouse
- Level off the hump on the bank at the barbecue end of rink one and resew the grass
- Make and fit a new shelf above the windows in the bar area to accommodate more trophies
- Cut back and maintain the overgrown vegetation surrounding the carpark at the western end
- After the carpet was replaced in the bar area, make up and fit new stained trim around the edges under the windows
- Modify the main Club front spouting, including making up two extra downpipes to ensure more take away of water in heavy falls preventing leaks into the interior and carpet
- Make repairs to both double doors (weather affected and timber cracked, paint poor) in the bar area
- Unblock the pipe linking the two stormwater drains in the carpark
- Paint out the top Club walls and trim; also touch up some ceiling patches ready for new carpet installation
- Replace a leaking tap in the ladies' bathroom in the top clubhouse
- Remove the overgrown hedge and broken lattice work from the front of the greenkeeper's shed, repaint the wall and trim. Prepare garden strip and replant.
- Make and fit a holding bracket to top shed wall to aid in the top green roller washing
- Highlight paint and safety tape to bump board in carpark space adjacent to top access gate
- Repair the wall around the Margaret St entrance gate and repaint the gate; hose down Club frontage path
- Reposition the lockers and cupboards in the dining area
- Wash down the outside of all main Club windows
- Refit, re-grout and seal loose tiles in a bathroom in the top clubhouse
- Mount and 'sign' a donated defibrillator in the top clubhouse
- Repair broken away patches of rendering on the main Club wall in the carpark
- Tidy up the mess around the top green garden tap and make up a new hose
- Tidy vegetation in the carpark again
- Repair, tidy up the wiring etc and replace the security system monitor in the office
- Cut up and remove overgrown branches and a fallen tree at the southern end of the carpark
- Replace a leaking tap in the ladies' bathroom in the top clubhouse
- Run a water supply to the rear of the bottom green shed for the purpose of washing down equipment. Also install a tap in that line at the barbecue area
- Replace a leaking tap in the ladies' bathroom in the top clubhouse
- Clean and prepare the barbecues (winter dirt and debris) and area ready for season events start up
- Replace all shades and infrastructure around greens
- Make and mount another holding bracket behind the bottom shed for washing the other roller
- Mount heat proof gloves and fire blanket to the barbecue trolley; modify//enlarge the gas bottle heat shield under the main barbecue and update the SOP for operators.
- Replace the dishwasher in the kitchen and connect a new drain hose
- The beer temprite system behind the bar was replaced, the old system removed, and the benchtop modified around it.

- The glass washer behind the bar was replaced. After a short period it was suggested it be relocated next to the sink and existing wet area. The area was modified to suit and the wooden benchtop covered in stainless steel
- Fit a new cupboard behind the bar in place of old glass washer.

I would like to thank Brian Coleman, David Anderson, Lindsay Lovell and Andrew Norris for their invaluable assistance with all these tasks.

## CASCADE WEDNESDAY BAREFOOT BOWLS

Wednesday Barefooters enjoyed another season combining fun with competitive bowls. Our greens were at full capacity, 28 teams of four, throughout the season. As usual, when the 13 *Divisional Roster* matches were completed, we ran *Handicap Roster* matches for the balance of the season. Alongside these matches we arranged 'special events' suited to the occasion; these were much appreciated and well patronised.

While Michael Seddon, Pat Wilkes and myself organised the season's activities, many Club members again provided great support through their endeavours and advice. Indeed, the ongoing success of Wednesday Barefoot is testament to the enthusiastic support of a large cohort of Club volunteers.

By early October, within the Club's Covid-19 arrangements, we had established a scheme which would enable our Barefoot Programme to operate effectively. By this time, we had also confirmed that our Sponsor, Cascade Hotel, would again provide weekly prizes.

**Matches.** Divisional Roster matches commenced on 14 October, as Mid-Week Pennant resumed. ## **CORPORATE EVENTS**

The Covid-19 pandemic caused a significant decrease in Corporate Events bookings for the 2020–2021 season. The Corporate Events and the Barefoot Bowls are the financial life blood of the Club and without these the Club would not survive.

## ICT REVIEW

In broad terms, the Information and Communications Technology Review, ICT Review, is proceeding well as we bring the Club's technology and people forward around ten years. Our strategy is timely as Bowls Australia is now providing ICT systems for innovative clubs wanting to improve results and save volunteer time. When our ICT platform is fully in place, and our volunteers understand how to use it, the Club will be able to more fully implement Bowls Australia's Bowslink and other system improvements.

In consultation with Michael Seddon, along the lines agreed by the President and the Board, I have -

- Engaged IRIS Computing, a local Tasmanian broad-based ICT provider, to support the Club in its ICT endeavours and to provide Helpline support.
- Designed a schema to ensure our ICT uses consistent, current, productive, secure features.
- Selected software providers of repute offering wide-ranging, proven, developing product that will meet the Club's foreseeable needs.
- Arranged Club email technology based on a new domain name *sandybaybowlsclub.com.au*
- Arranged a new computer (PC) with Microsoft Office 365 (MS365), replacing the main office PC (*Secretary's PC*).
- To solve a security deficiency, arranged a new bar POS computer and upgraded software, and checked correct interaction with new main office PC.
- Re-arranged the Club wireless network to solve a security deficiency.
- Upgraded the Admin PC with a solid-state hard-drive and MS365, so that (a) it can be used by the club office people who don't need access to the main office PC, and (b) it is available to be used by the Secretary/Treasurer etc as a backup PC should the main office PC be down or in use by someone else.
- Upgraded the Bar PC with a Windows 10 PC running MS365, so that authorised users can readily access or print their data without needing access to the Club office.
- Replaced the 'office copier' with a networked mono-laser printer.
- Linked the TV to the Club network to enable raffle draws etc to be displayed.

Both the Secretary and the Treasurer now have access to a properly-secured, reliable Club PC running current office software (MS365) with cloud-based backup available. The Treasurer now also has access to his systems, data and email from his home PC. Similar access has been enabled for the Secretary to access to her systems, data and email from her laptop.

With the Club's ongoing support, I plan to continue work, along with Michael Seddon and IRIS, to complete the ICT platform upgrade as proposed. Some of the finer points are yet to be resolved; while pennant, practice and barefoot management are in abeyance, more focus here is proposed.

Once the new ICT Platform is well-established and contracted ICT Support is operating satisfactorily, I propose that the Club move properly into the Information Age and work with its volunteers to record their operational schemas and data within the Club's ICT Platform.

## **TREASURER'S REPORT**

Another extraordinary financial year.

### **Overall results**

The clubhouse was closed from mid-March 2020 until July 2020 resulting in a loss of bar income, particularly in April, and the loss of Probus monies.

However, the Club received \$9,000 in JobKeeper payments, all of which were passed onto the bar attendant, \$27,525 + GST in Covid-19 grants from the Tasmanian Government and \$19,545 grants from the Australian Government resulting in a surplus for the year of \$34,467.

The Club's Operating Deficit, which excludes these grants, for the year was \$12,604, compared with \$8,081 in 2019/20; however, once depreciation is taken into account the Club's Net Cash Flow from Operating Activities was \$17,487 compared with \$1,447 in 2019/20.

### **Bar results**

With the bar being closed during early months of the year, Sales were down by about \$10,000 compared with both 2018/19 and 2019/20.

However, the Bar Gross Profit percentage returned to the historic percentage of just over 60%, correcting the 57% experienced in 2019/20.

### **Liquidity**

The Club's liquidity was in a healthy position at year end, with the Club's Working Capital (i.e. Current Assets less Current Liabilities) at 31<sup>st</sup> March 2021 being \$129,620 resulting in the Club being able to make a contribution towards a synthetic green.

### **Thanks**

The Club's strong financial position is very much due to the efforts of a number of members. Without these members the Club would be much worse off financially.

Finally, a special thanks to Jan Hobbs who has been Assistant Treasurer and who has provided so much assistance to me throughout the year.

**Notes to and forming part of the financial statements**  
**for the year ended 31 March 2021**

**1 Basis of Financial Reporting**

The Club's Board has determined that the Club is a "non-reporting entity" within the meaning of Statement of Accounting Concepts - "Definition of the Reporting Entity" issued by the Professional Australian Accounting Bodies. It has further determined to prepare a "special purpose financial report" annually based on accrual accounting principles and comprising a Balance Sheet, an Income Statement and a Statement of Cash Flows.

The policies used in preparing this special purpose financial report are, in the opinion of the Board, consistent with the Club's Constitution and are appropriate to the needs of Members. These policies are described in the following notes.

**2 Covid-19 virus**

As a result of Covid-19 restrictions the clubhouse was closed from mid-March to mid-July 2020. This resulted in material losses of income from Probus clubs and from bar takings. During the period the clubhouse was closed the Australian Government paid the Club a JobKeeper subsidy of \$9,000, all of which was paid to the Club's employee.

The Club received a Covid-19 grant from the Tasmanian Government of \$27,525 and a Covid-19 Cash Flow grant from the Australian Government of \$19,545 during the year.

**3 Non bar expenses**

Catering, bowls apparel, stickers & equipment and the use of cars & hire of buses are shown net of recouped monies.

**4 Inventories**

Inventories are shown at the lower of cost or net realizable value.

**5 Land and Buildings**

The value of the Club's Land and Buildings was increased at 31<sup>st</sup> March 2015 to the valuation by the Valuer General made in 2015. Alterations to the clubhouses made since 1<sup>st</sup> April 2015 are shown at historic cost.

Provision for depreciation is made based on the buildings' value at 1<sup>st</sup> April 2015, the historical cost of alterations since 1<sup>st</sup> April 2015 and the buildings' useful lives.

**6 Other Non Current Assets**

Other Non Current Assets are shown at historic cost and acquisitions costing \$1,000 or more are capitalised.

Provision for depreciation is made based on assets, historical cost and are depreciated over their useful lives.

## **Audit Opinion**

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

## **Independence**

To the best of my knowledge and belief, there has been no contravention of auditor independence and any applicable code of professional conduct in relation to the audit.



